RESOLUTION TO FILL A VACANCY IN NOMINATION WHERE NO CANDIDATE WAS NOMINATED AT THE GENERAL PRIMARY ELECTION

WHEREAS, a vacancy in the nomination of the Republican Party for the office of Regional Superintendent of Schools for the Kane County Educational Services Region, State of Illinois was created by the resignation of the incumbent office holder, Douglas Johnson, effective March 1, 2012; and

WHEREAS, the said incumbent was elected at the November, 2010 General Election for a term of four years commencing July 1, 2011, and ending June 30, 2015; and

WHEREAS, by reason thereof, the vacancy in the office of Kane County Regional Superintendent of Schools occurred more than 28 months prior to the expiration of the term of office for which the incumbent was elected at the 2010 General Election; and

WHEREAS, by reason thereof, the vacancy in office is required to be filled at the November 6, 2012 General Election for the balance of the unexpired term of the Regional Superintendent of Schools; and

WHEREAS, no candidate was nominated by the Republican Party at the General Primary Election on March 20, 2012 because the vacancy in office occurred after the last day for candidates to file petitions for nomination at the General Primary Election and after the last day to file a declaration to be a write-in candidate, and therefore no candidate could have filed nomination papers for the unexpired term; and

WHEREAS, the Republican Party desires to nominate a candidate to appear on the November 6, 2012 General Election Ballot for the unexpired term for the office of Regional Superintendent of Schools for the Kane County Educational Services Region, also known as the Kane County Regional Superintendent of Schools; and

WHEREAS, Section 3A-6 (c)(3) of the School Code, 105 ILCS 5/3A-6 (c) (3) provides that a vacancy in the nomination shall be filled by the County Central Committee as provided in Section 7-8 of the Election Code; and

WHEREAS, the Kane County Republican Central Committee was duly convened on April 18 pursuant to notice, at which time a quorum was present; and

WHEREAS, PATRICIA DAL SANTO was duly nominated by the Kane County Republican Central Committee at said meeting as the Republican candidate for the office of Kane County Regional Superintendent of Schools.
