

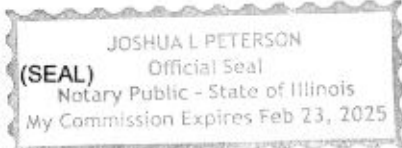

## CODE OF FAIR CAMPAIGN PRACTICES

- (7) I will immediately and publicly repudiate methods and tactics that may come from others that I have pledged not to use or condone. I shall take firm action against any subordinate who violates any provision of this Code of the laws governing elections.
